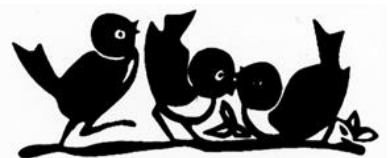
Wander Trails

Cancellation period: Cancellation fee
